6:40pm- Discussing Partnership/Merger with WDNA:

Referencing previous discussions, we have covered pros and cons of opinion and fact. Next step is to seek guidance from the city – What is WDNA's neighborhood plan and obligations? Concern voiced over a merger leading to more work for the WENA board without obvious benefit.

Discussion: Kelley Tagg, President of WDNA is a great resource within the political and city arena. Has organized political forums prior to local elections and coordinated candidates who attended NNO. Could a merger increase our utilization of an active relationship with the City? We can increase being a platform for our residents to become more involved in city planning that directly affects them. Idea of a trail merger presented.

Justin Buckley, WENA resident, offers his skills and interest in project development as a liaison for the potential merger with a year-long time frame in mind. It is then proposed that Justin be appointed to an open board seat allowing him to be an official representative of the board while facilitating potentially merging with WDNA. As with any individual appointed to the WENA board, Justin is asked to bring ideas and any progress made to the next meeting in due diligence, before an appointment is made.

Safe Exchange location – Could the BPD Downtown Station at 22nd & Fairview be used as a safe exchange location?
